


Gender-based Violence and Domestic Violence: An area of cooperation between EU and EEA EFTA states

- The Agreement on the European Economic Area (EEA) is the cornerstone of relations between Norway and the EU. It brings together the 28 EU member states and the three EEA EFTA states Norway, Iceland and Liechtenstein in the internal market governed by the same basic rules.
- Norway provides funding to 16 EU countries in Central and Southern Europe through the EEA and Norway Grants. The aim of the Grants is to reduce economic and social disparities and strengthen bilateral relations.
- Combating domestic and gender-based violence is included as a specific area of support in almost all the 16 beneficiary countries in Central and Southern Europe, measures are supported in several program areas across sectors.




Common Challenge: Insufficient protection

Violence against women constitutes a serious human right violation according to global human right standards like those set in the UN Convention on the Elimination of All Forms of Discrimination against Women (CEDAW Convention), the Beijing Platform for Action (BPA), the UN Declaration on the Elimination of Violence against Women (DEVAW) and the UNSCR 1325.

Despite that governments recognize their responsibility, the due diligence, to eliminate all forms of violence against women, *the violence is endemic throughout Europe*. Women and girls are not getting sufficient protection against these forms of violence.

Violence against women is more common in Europe than you may think

- 1 in 3 women has experienced sexual violence, physical violence, or both
- 1 in 3 has experienced psychologically abusive behaviour by an intimate partner
- 1 in 5 has experienced stalking
- More than 1 in 2 have experienced sexual harassment
- 1 in 20 has been raped
- 95 % of victims of trafficking for sexual exploitation in the EU are women


Common Platform: The standards set by the Istanbul Convention

The 7 Cs of the Istanbul Convention

1. Centred around victim rights (Art. 7)
2. Comprehensive (Art. 7)
3. Coordinated (Art. 7)
4. Capital allocation (Art. 8)
5. Civil Society involvement (Art. 9)
6. Coordinating body/bodies (Art 10)
7. Collection of data and research (Art. 11)
